Re: FY 2024 Budget Request

Dear Commissioners:

The predator board would like to thank the Sublette County Commission for your willingness to consider the board's budget request of \$50,000 (the same as last year).

**Our Operations:** The Sublette County Predator Board has always been a lean and efficient operation with little expenditures outside of paying for active predator control through our annual contract with USDA Wildlife Services. Sublette County reimburses the predator board for work conducted by Wildlife Services, up to the amount allocated by the county commission. Any further predator control is funded through predator fees collected during brand inspections on livestock. All other predator board expenditures are covered by the predator fees paid by livestock producers – not from funds allocated by Sublette County.

**Predator fees** are collected with brand inspections. In Sublette County, that amount is 60 cents per head for sheep and 20 cents per head for cattle. This has generated just over \$10,000 in the current year, and with the exception of general fund contributions from the Sublette County Commission, and interest earned at the bank, is the only revenue received by the predator board. This year's decrease in revenue from predator fees is something we are watching closely, and we've requested the Wyoming Livestock Board conduct an investigation into the accuracy of accounting of predator fees paid on Sublette County livestock.

**Budget changes:** The proposed budget also reflects increases in the cost of providing animal damage control services. With this winter's severity, we have done more aerial predator control while there was still snow on the ground, both to provide relief to agricultural producers during livestock birthing seasons as well as to assist big game herds. We anticipate increasing these efforts next winter as well.

**The Board:** The board consists of seven volunteers: three cattle producers and three sheep producers elected by fellow livestock producers, and one sportsman appointed by the Sublette County Commission. We have no office or no paid staff and hold our administrative costs low (budgeted at \$800). Outside of this \$800, all expenditures made by the board go directly to animal damage control.

**Conclusion:** Every dollar of County funding that is spent by this board goes directly to control work to reduce damage to livestock and wildlife populations, or to protect human health by controlling ravens.
