

**OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
SEPTEMBER 6, 2016**

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, Jim Latta, Stephen Crane of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of August 23, 2016, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Latta. The motion carried.

The official bond for Cindy L. Armstrong, Deputy Clerk for the Town of Marbleton, in the amount of \$50,000 was approved and ordered filed with the County Treasurer.

Butch Penton, Road and Bridge Superintendent, reported on the dyke at the Green River, the dug way on Dell Creek, the Ehman Lane easements, the Skyline Drive construction project, and the road south of Fremont Lake.

Mark Eatinger, representing Rio Verde Engineering, reported that HK Construction will begin the chip seal projects this week, and that Teletractors will be completing their projects at the County Attorney's Office and the Marbleton Landfill this week.

Mike Jackson, representing Rio Verde Engineering, reported that the drainage project at the Marbleton Senior Center will be complete this week.

County Surveyor Skylar Wilson discussed the Boulder Travel Management Plan.

Ron Gordon, representing Waste Management, discussed tipping fees. The Board requested updated information on receipts and expenditures for discussion at the October 4<sup>th</sup> meeting for decision making. It was moved by Commissioner Latta and seconded by Commissioner Bousman to approve and sign the contract with Rio Verde Engineering for landfill engineering. The motion carried. Mike Jackson, representing Rio Verde Engineering, reported that a meeting with DEQ is scheduled to review the County's permit.

The following petition and affidavit of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Lance Oil and Gas Company, Inc., \$1,946.17, and Amanda Frank, \$219.42.

The Board signed the Schedule A agreement with the Forest Service.

Old Business. Commissioner Latta reported no old business. Commissioner Bousman reported on WPLI, the Boulder Travel Management Plan, Sagebrush Focal Areas, quarterly BLM meetings and the beginning of similar meetings with the Forest Service, Mule Deer migration corridors, and his trip around the county to review roads with Butch Penton. Chairman Nelson reported no old business.

Sheriff KC Lehr reported on meeting with the County Clerk on budgets.

Maxine Leckie inquired about signs and reducing speed limits. The Board reported that it had discussed these issues with WYDOT and Representative Albert Sommers.

In accordance with the public notice published in the Pinedale Roundup on August 19, 2016, public hearing was held for the following:

1. It was moved by Commissioner Latta and seconded by Commissioner Bousman to approve a request for a Conditional Use permit by Wapika Ranch, LLC for the development of a private golf course within the A-1 zoning district, with no public use, including nine holes and encompassing approximately 49 acres, located in Section 8, T31N, R110W. The motion carried.
2. It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve a variance request by Union Wireless to allow a cell phone tower to be constructed to a maximum height of 65

feet in the R-R zoning district, where the maximum height allowed is 30 feet, located in Section 21, T33N, R108W. The motion carried.

Todd Hurd, representing Forsgren and Associates, and Maintenance Superintendent Andre' Irej reviewed the following projects:

1. Extension Office. Substantially complete on August 31, 2016. Final walk through for punch list items will be tomorrow.
2. Circuit Court Roof. Need updated insurance.
3. County Attorney Roof. Parapet wall will begin this week with American Roofing scheduled for next week.

Andre' Irej, Maintenance Superintendent, reported on the Big Piney Ambulance Barn, the proposed key system for the Ice Arena, and that the sidewalks were complete at Aspen Ridge.

Chairman Nelson thanked Dan Liske for the great work on his recent projects.

Kate Dahl, Debbie Woyciesjes, and Rachel Grimes, representing Main Street Pinedale requested permission to locate a 10 bike docking station at the Sublette County Visitors Center. The Board approved the request.

Sam Bixler, representing the High Meadow Ranch Water District, requested two letters of support for grant applications, for the purpose of maintaining and upgrading the infrastructure in the District and continuing to serve the community with safe and reliable drinking water. The Board approved the request and signed the letters.
