OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MAY 16, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Stephen Crane of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of May 2, 2017, were approved and ordered filed on motion by Commissioner Rawhouser and seconded by Commissioner Burnett. The motion carried.

The official bond was approved for Bill Mecham, Treasurer for the Pinedale Airport Board, in the amount of \$2,500 was ordered filed with the County Treasurer.

Butch Penton, Road & Bridge Superintendent, reported on levy improvements, slides at Dell Creek and Jack Creek, fencing, rocks for the Game and Fish, and repairs to the hydro seeder.

Mark Eatinger, representing Rio Verde Engineering, presented the bids for the 2017 Chip Seal project. It was moved by Commissioner Noble and seconded by Commissioner Bousman to accept the bid from HK Contractors, Inc. in the amount of \$1,220,777.00. The motion carried. It was reported that the Industrial Site project was in progress.

Commissioner Noble inquired if the County's chips would be depleted with the project, just awarded, and was informed that they would not.

Mike Jackson, representing Rio Verde Engineering, presented the County's two FLAP grant applications. It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to approve two applications to be submitted for FLAP funding, being Phase II of Skyline Drive and the Green River Lakes Road. The motion carried. A discussion followed about the maintenance commitment on the Green River Lakes Road, if the grant is approved.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to amend the Forest Service Schedule A contract to designate \$16,000 for dust suppression on Forest Service Road 111. The motion carried.

Mayor Bob Jones requested the Board to provide the 9.5 percent matching funds for the Pinedale FLAP grant for Forest Service Road 111. No action was taken by the Board.

Ron Gordon, Waste Management, and Mike Jackson, representing Rio Verde Engineering, reported on a recent DEQ meeting in Lander.

Shad Cooper, County Fire Warden, presented his monthly report and invited the Board to the Annual Catfish Fry in Marbleton on May 20th. Commissioner Noble inquired about DOT inspections and remote water stations. Commissioner Burnett discussed medical services.

Sheriff KC Lehr discussed long range communications issues. The Board directed the County Clerk to invite WYDOT Director Bill Panos to a meeting during the week of June 5th. Sheriff Lehr reported on the contract helicopter.

Chairman Andy Nelson requested an update on sandbagging.

Justin Wilkerson, representing New York Life Insurance, reported that 10% of the County employees had applied for whole life insurance. It was moved by Commissioner Rawhouser and seconded by Commissioner Noble to institute payroll deduction from the whole life premiums for New York Life. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve a contract for the operation of the Pro Shop at Rendezvous Meadows Golf Course to P&G Golf LLC. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to accept, with appreciation, a resignation letter from Rachel Grimes from the Recreation Board. The motion carried.

The following abatement petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: BP America Production Company, \$641,869.59; BP America Production Company, \$81,035.09; BP America Production Company, \$1,431.48; BP American Production Company, \$863.16; BP America Production Company, \$2,285.75; BP America Production Company, \$4,932.10; BP American Production Company, \$2,789.89; and Anadarko E & P Onshore, LLC, \$14,826.19.

It was moved by Commissioner Burnett and seconded by Commissioner Noble to issue a catering permit to the Boulder Bar & Grill for the Todd Stevie Horse Sale on June 10, 2017 at the Events Center. The motion carried.

Old Business. Commissioner Rawhouser reported on Extraterritorial Jurisdictions for Planning and Zoning and consolidation of Works Compensation at the WCCA meeting, and inspecting roads with Butch Penton. Commissioner Noble reported on the Energy committee, air quality, and a mine tour at the WCCA meeting. Commissioner Burnett reported on the Safety committee at the WCCA meeting, and the DEQ meeting in Lander. Commissioner Bousman reported that the WCCA budget will remain the same this year and that the Public Lands committee discussed Natural Resource Plans, Healthy Forests, and BLM perpetual easements.

In accordance with the public notice published in the <u>Pinedale Roundup</u> on April 28, 2017, public hearing was held for the following:

1. It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve the Greenwood Minor Subdivision, zoned R-R 5, located in Section 32, Township 30N, Range 111W. The motion carried.

County Planner Bart Myers updated the Board on the upcoming WPLI tours.

Andre' Irey, Maintenance Superintendent, requested approval of the purchase of a trailer. The Board approved the request.

Chairman Nelson informed the Board that the Liquor License renewals have been postponed until 2 p.m. at the next meeting on June 6^{th} and that the Resolution establishing new regulations will be considered at the same time.

Chairman Nelson discussed a letter from the Department of Health concerning the appointment of High Country Behavioral Health at a Title 25 Gatekeeper. The letter was referred to the County Attorney.

Chairman Nelson reported on the designation of the Cora Townsite as a National Register Historical Place.

It was reported that the Denbury EA is available to the public.

Stan Zierlein expressed his concern about the recent changes in Liquor laws.

The Board discussed the road easement on the Budd property on South Piney Fish Creek. Commissioner Bousman is corresponding with Karen Budd-Falen on the situation.

Chairman Nelson reported on the AQC meeting, the community visit by UW President Laurie Nichols, appointed Commissioner Noble to the WYDOT Advisory Committee, discussed the emergency generator at Mt. Airy, and informed the Board the he and Commissioner Burnett will meet with the St. John's Hospital Administrator on June 7th.
