## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS JUNE 6, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Stephen Crane of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting May 16, 2017, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Rawhouser. The motion carried.

Chairman Nelson dedicated a moment of silence to the memory of Bart Myers, the Sublette County Planner, for the past 11 years, who unexpected passed away, yesterday, and wished him God speed.

The official bonds for Spencer Nichols, President of the Big Piney Cemetery District, in the amount of \$1,000; Peggy Winters, Treasurer for Mosquito Abatement District #1, in the amount of \$1,000; Wilma Shriver, Treasurer for the Upper Green River Cemetery District, in the amount of \$1,000; Anita Bohm, Treasurer for the Town of Marbleton, in the amount of \$50,000; Vern McAdams, Business Manager for School District #1, in the amount of \$250,000; and Chris James Nelson, Treasurer for School District #1, in the amount of \$250,000; and ordered filed with the County Treasurer.

A land access agreement with Douglas J. and Lynda Vickrey was presented for the purpose of bank stabilization next to Pape County Road. It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve and authorize the Chairman to sign the agreement. The motion carried.

Chairman Nelson acknowledged Joel Bousman for his hard work as the Western Interstate Region President of the National Association of Counties.

Butch Penton, Road & Bridge Superintendent, reported on meeting with the Forest Service concerning drain ditches on the Dell Creek Road, flooding on the Upper Hoback River Road, the speed limit reduction to 65 miles per hour at the Rim, washout on the Jack Creek Road, and washouts on the Willow Lake Road.

Skylar Wilson, County Surveyor, reported on the County's BLM perpetual easements.

Ron Trowbridge, representing Trowbridge Consulting, LLC, discussed providing audit review of State oil and gas audits for the County. The Board requested a proposal.

Ron Gordon, Waste Management, and Mike Jackson, representing Rio Verde Engineering, discussed 28 additional borings at the Marbleton Landfill at a cost of \$18,840. Gordon offered his personal equipment to save on the cost, which the Board declined. Gordon requested that the engineering costs in his budget be moved to a capital cost instead of an operating cost, which was declined. The Pinedale free dump day concerns about safety and chaos was discussed. It was suggested that more free dump days may resolve the chaos. Commissioner Bousman discussed the mobile homes in the Daniels Trailer Park south of Big Piney. The Board had been informed that a community group was considering a clean-up of the area.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to provide a letter of support for the relocation of the transformer on the property adjacent to the Museum of the Mountain Man. The motion carried.

At the request of County Clerk Mary Lankford, it was moved by Commissioner Bousman and seconded by Commissioner Burnett to recess the meeting into an Executive Session with Ron Gordon, and Deputy County Attorney Matt Gaffney to discuss personnel, in accordance with W.S. 16-4-405(a)(ii). The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to reconvene the meeting.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve the 38 hours of overtime requested by Ron Gordon for the May pay period. The motion carried.

Robin Schamber, representing UW Extension, presented two agreements for approval. It was moved by Commissioner Bousman and seconded by Commissioner Noble to approve the annual contract and the compensation agreement for 4-H Services with the University Extension. The motion carried. Schamber discussed the purchase of a tractor with grant funds by the 4-H Foundation. The Board referred her to the County Attorney for an agreement on the use of the tractor on County property.

Mike Henn, representing the Sublette County Conservation District, discussed the Crandall Ditch and the availability of funding for its repair from the NRCS. Chairman Nelson advised the Board that he had approved and signed a letter with the Sublette County Conservation District on June 2, 2017 in support of securing the funding. It was moved by Commissioner Burnett and seconded by Commissioner Bousman to ratify the Chairman's letter. The motion carried.

Sheriff KC Lehr discussed the WyoLink meeting and informed the Board that the upcoming weekend will be busy.

Old Business. Commissioner Rawhouser reported on the Veterans Service Officer interviews, the upcoming Forest Collaborative meeting on June 21<sup>st,</sup> and the Hoback Ranches Service and Improvement District meeting on June 17th. Commissioner Noble reported on the Sharkey broadband study, Workforce Services, the generator on Mt. Airy, and the completion inspection of Skyline Drive. Commissioner Burnett had nothing to report. Commissioner Bousman reported on the WIR meeting in Oregon, the order to start over on the Planning 2.0 process, and meeting with Trish O'Connor, B-T Forest Supervisor, to discuss rocks on Skyline Drive, with the meeting scheduled for June 16th. Chairman Nelson appointed Commissioner Noble to participate in the WYDOT Advisory Committee and suggest a replacement for the County on the ENDOW initiative.

At the request of Chairman Nelson, it was moved by Commissioner Burnett and seconded by Commissioner Noble to recess the meeting into an Executive Session to discuss personnel, in accordance with W.S. 16-4-405(a)(ii). The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Noble to reconvene the meeting.

Wendy Boman, representing the Rural Health Care District, reported on the affiliation agreement and a proposed contract with consultant Mark Cross.

Kay Malkowski discussed working with the Rural Health Care District. The Board discussed the affiliation agreement and uncertainty of Federal funding. Maxine Leckie concurred.

Lauren Conrad, representing Climb Wyoming, presented a program overview of services provided to low income single women in Teton, Lincoln, and Sublette County.

It was moved by Commissioner Rawhouser and seconded by Commissioner Bousman to have the Sand Draw Ambulance Barn and property appraised for sale. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to accept the Letter of Engagement from Leo Riley and Company for the FY17 Financial Audit in the amount of \$36,500. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to issue a malt beverage permit to the Pinedale Lions Club for the Rendezvous BBQ on July 9, 2017 at the Rendezvous Grounds. The motion carried.

The following petition and affidavit of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Ultra Resources, Inc., \$29,453.03; Williams Production Rocky Mountain, \$449.31; Exxon Mobil Corporation, \$17,683.34; and Exxonmobil Oil Corporation, \$7,154.06.

Todd Hurd, representing Forsgren and Associates, and Andre' Irey, Maintenance Superintendent discussed the following projects:

- 6. Storm Drain on Mill Street. Meeting with the Pinedale Mayor.
- 7. Pinedale Clinic. Second water heater has been replaced.
- 8. Boiler Maintenance in County buildings.
- 9. Bollards for Circuit Court. Searching for bollards for the entry way.
- 10. Aspen Grove. Shower repair for leaking. Resident was moved.
- 11. Marbleton Clinic. Asphalt repair approved.
- 12. 4-H Building. Drainage plan approved.
