OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS SEPTEMBER 5, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Lance Nixon of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of August 22, 2017, and special meeting of August 23, 2017, were approved and ordered filed on motion by Commissioner Rawhouser and seconded by Commissioner Noble. The motion carried.

The official bonds for Cindy L. Armstrong, Deputy Clerk for the Town of Marbleton, in the amount of \$50,000; David Nemetz, Treasurer for the Hoback Ranches Service and Improvement District, in the amount of \$5,000; and Roger Weber, Clerk/Treasurer for the Shelter Park Improvement District, in the amount of \$20,000 were approved and ordered filed with the County Treasurer.

Pinedale Mayor Bob Jones requested the scoping and matching funds for Forest Service Road 111 to the Lower Boat Dock at Fremont Lake, in the amount of approximately \$300,000. After discussion, it was moved by Commissioner Noble and seconded by Commissioner Burnett to fund the \$10,000 for the scoping, and provide the 9.51% matching funds from future Consensus Funding. The motion carried, with the vote being: Nelson-aye, Burnett-aye, Noble-aye, Rawhouser-aye, and Bousman-nay.

Jason Spaeth and Mark Noble, representing the Bar Cross Ranch, reported that there was no gravel in the hill in the proposed easement. Culverts were discussed. The Board agreed with the redesign, to meet County Road Standards, with the County providing the culverts for the realignment. It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to advertise the realignment of the Willow Creek County Road No. 23-120 for a public hearing. The motion carried, with the vote being: Nelson-aye, Bousman-aye, Burnett-aye, Rawhouser-aye, and Noble-abstained.

It was moved by Commissioner Burnett and seconded by Commissioner Noble to approve the landowner agreements with KM Cattle Company and JF Ranch for bank stabilization. The motion carried.

Butch Penton, Road and Bridge Superintendent, reported on a contact from David Nemetz of Hoback Ranches and a request for fencing from Ty Anderson. Penton reported that he informed Anderson that additional easements will be required.

The Board discussed the Skyline Drive, Phase II scoping funding, and the rocks in both phases. It was moved by Commissioner Noble and seconded by Commissioner Bousman to approve \$10,000 for the scoping for Skyline Drive, Phase II. The motion carried.

Mark Eatinger, representing Rio Verde Engineering, reported that gravel crushing manuals will be available this week, that the Industrial Site project will be finished by September 30th, that more striping is needed on the chip seal projects, and that asphalt will be complete next week.

Commissioner Bousman reported on the Dell Creek and McKee Pit accesses.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to recess the meeting for an Executive Session, with Butch Penton, Billy Pape, and Deputy County Attorney Matt Gaffney, in accordance with W.S. 16-4-405(a)(iii) to discuss potential litigation. The motion carried.

The Board excused Penton and Pape and continued in Executive Session, in accordance with W.S. 16-4-405(a)(ii) to discuss personnel.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to reconvene the meeting.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to deny a claim submitted by Marilyn Filkins in the amount of \$1,558.59 for vehicle repairs. The motion carried, with the vote being: Bousman-aye, Burnett-aye, Noble-aye, Rawhouser-aye, and Nelson-nay.

Billy Pape, Waste Management interim supervisor, reported on recycling, tires, paint, household trash in the C&D waste, hours of operation, and equipment. It was suggested that there should be a fine of \$500 for household trash in C&D waste. No action was taken.

Old Business. Commissioner Rawhouser reported on touring the Willow Creek County Road and Hoback Ranches. Commissioner Noble reported on the CenturyLink meeting, Union Cellular meeting, and meeting with Joe Sharkey and Dave Smith. Commissioner Burnett reported that he accompanied Commissioner Rawhouser on his tours. Commissioner Bousman reported on the Forest Collaborative, upcoming PILT & SRS flying to Washington, DC, and WIR. Commissioner Nelson reported no old business, and conversations with citizens.

Kay Malkowski polled the Commission about their attendance at the CAH Strategic Planning meetings.

Todd Hurd, representing Forsgren and Associates, and Maintenance Superintendent Andre' Irey reviewed the following projects:

- 1. Pinedale Fire Hall. Tin veneer proposed.
- 2. Courthouse Storm Drain. Plans are ready for distribution.
- 3. Fire Training Facility. Questar has an easement for the gas line project.

Andre' Irey, Maintenance Superintendent, reported on replacing the lights at the Big Piney Library and that Grant Golden has been hired to be the Ice Arena Manager.

Joe Sharkey presented his preliminary report on the broadband assessment project. Electronic copies of his presentation were made available to the public.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to appoint Allison Long and Scott Cheeney to the Golf Committee. The motion carried.

The following petition and affidavit of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: ExxonMobil Oil Corporation, \$14,436.31.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to recess the meeting for an Executive Session, by conference call with John McKinley, representing Davis and Cannon, and Deputy County Attorney Matt Gaffney, in accordance with W.S. 16-4-405(a)(iii) to discuss potential litigation. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to reconvene the meeting.

McKinley and Representative Albert Sommers discussed mineral tax liens.
