OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS FEBRUARY 6, 2018

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Holly Dabb, representing the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of January 16, 2018, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Noble. The motion carried.

The official bond was approved for the Recreation Board for School District #9, in the amount of \$50,000 and ordered filed with the County Treasurer.

The Board discussed a proposed easement from Robert Harrower on the LaBarge Creek Road.

Mike Jackson, representing Rio Verde Engineering, reported that the Skyline Drive easement was about complete.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to withdraw the easements that are less than 200 feet on the BLM sections and replace with 200 feet easements on Skyline Drive. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve the SF299 application for the Lander Cutoff Road easement and to adopt Resolution No. 18-100319N to accompany the application. The motion carried.

It was moved by Commissioner Rawhouser and seconded by Commissioner Burnett to adopt Resolution No. 18-100320N accepting additional easement on the Middle Piney County Road. The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve and authorize the Chairman to sign a quit claim deed to the Town of Pinedale for property on Orcutt Hill. The motion carried and the quit claim deed was signed.

Butch Penton, Road and Bridge Superintendent, discussed the water line in Barger Subdivision.

Billy Pape, Waste Management Superintendent, presented a status report on the DEQ permit modification, and reported on the baler, tires, and sharps disposal.

The Board met with Joanne Hovis, representing CTC Technology and Energy, concerning a proposal to provide services to assist the Broadband project, GIG Sublette. It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to contract for services with CTC. The motion carried.

Cassie Crumpton, representing Treatment Court, provided a program update and discussed the scram system and recidivism.

Old Business. Commissioner Rawhouser reported on meeting with Bob Harrower on an easement for the LaBarge Creek Road, attending the Fire Banquet, Forest Collaborative meeting, and participating in a conference call on Workers Compensation. Commissioner Noble reported on the Broadband meeting, CLG meeting, and attending the Fire Banquet. Commissioner Burnett reported on the Courthouse Security meeting and the group's new Chairman, Judge Curt Hawes, and participating in a conference call on PMO and the state Prevention program. Commissioner Bousman discussed the WPLI project and conflict with the County's public lands use policy, attendance at the Western Governors Meeting and socio-economic baseline information in Wyoming counties, attendance at a Department of Interior meeting in Salt Lake City on the Department's reorganization, and a WCCA conference call on Extension benefits. Chairman Nelson had nothing to report.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to recess the meeting for an Executive Session, with John McKinley, representing Davis and Cannon, by conference call, in accordance with W.S. 16-4-405(a)(iii) to discuss litigation. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to reconvene the meeting.

McKinley reported the Vanguard bankruptcy hearing was conducted in Houston, Texas yesterday, February 5, 2018. County Treasurer Roxanna Jensen was present and testified by behalf of Sublette County. The Judge ruled from the bench in favor of Sublette County. The order will be filed in the next few days, and there is a 14 day appeal period.

The motion carried.
- 2. It was moved by Commissioner Noble and seconded by Commissioner Burnett to approve the Quaker Patch Minor Subdivision by the Evans Family Holdings. The motion carried.
- 3. It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to deny a variance application of the maximum square footage of a guest house/cabin, by Gorge S. and Lisa M. Hall, located in Section 10, T37N, R113W. The motion carried.

It was moved by Commissioner Rawhouser and seconded by Commissioner Noble to recess the meeting for an Executive Session, with County Fire Warden Shad Cooper and Sheriff KC Lehr, in accordance with W.S. 16-4-405(a)(ix) to receive confidential information. The motion carried.

It was moved by Commissioner Rawhouser and seconded by Commissioner Noble to reconvene the meeting.
