## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS JULY 17, 2018

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Holly Dabb of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of July 3, 2018, was approved and ordered filed on motion by Commissioner Burnett and seconded by Commissioner Bousman. The motion carried.

The Board reviewed the Final Budget Summary, the Appropriation Resolution, and the Resolution To Provide Income Necessary to Finance the Budget. It was moved by Commissioner Bousman and seconded by Commissioner Burnett to adopt the FY19 Appropriation Resolution and the FY18 Resolution To Provide Income Necessary to Finance the Budget. The motion carried, and the resolutions were signed.

Commissioners Burnett and Rawhouser thanked County Clerk Mary Lankford for her work on this year's budget. County Clerk Mary Lankford acknowledged and thanked her Chief Deputy Tracey Hoover for her work on the County budget, this year and in past years.

The official bond for the Library Board, in the amount of \$5,000, was approved and ordered filed with the County Treasurer.

Aaron Seehafer, representing Rio Verde Engineering, reported on the BLM easement to Trappers Point. The expansion of the scope of work to include pull outs and bus access was discussed. The Board approved the completion of a BLM application for the easement.

Mike Jackson, representing Rio Verde Engineering, discussed the easement for the Lander Cutoff, and reported on a meeting with High Meadow Water District concerning Meadowlark and Iroquois, and the restriction on boring and road cuts by the District of the County road.

Billy Pape, Assistant Road and Bridge Superintendent, reported on the chip seal and crack seal projects, the condition of the road to Kismet Peak, and the Cottonwood crushing project.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to authorize an additional 15,000 yards of gravel by Green River Rock, Inc., at \$6.12 per yard, from the Cottonwood Pit. The motion carried.

Pape reported on the County crusher at the Beaver Pit, 30 percent price increase on the culverts for the Willow Creek road project, and maintenance work.

Billy Pape, Waste Management Manager, reported that the DEQ meeting to review the County permit will be July 26<sup>th</sup>. The hydrant at Recycling is being moved.

It was moved by Commissioner Rawhouser and seconded by Commissioner Burnett to recess the meeting into an Executive Session, with Deputy County Attorney Matt Gaffney, to discuss potential litigation, in accordance with W.S. 16-4-405(a)(iii). The motion carried.

It was moved by Commissioner Rawhouser and seconded by Commissioner Burnett to reconvene the meeting.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to opt into Kane County vs. the United States concerning PILT reimbursement shortages. The motion carried.

County Fire Warden Shad Cooper presented his monthly SCUF report. Cooper reported on the 2020 Wardens Association training. Commissioner Bousman reported on the new recruit graduation and commended Cooper for doing a great job. Cooper updated on the Harris Project. The Board directed that a letter be sent to Pape Ranches relinquishing ownership of the tower and building abandoned on Aspen Ridge.

Sheriff KC Lehr reported on Rendezvous and that 43 people are currently in the Detention Center. Lehr reported on a SAR mission to assist Johnson County with an injured hiker, and a recovery.

It was moved by Commissioner Noble and seconded by Commissioner Burnett to designate the Bank of Jackson Hole, dba Bank of Sublette County, as an official depository of public funds. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to designate August 3, 2018, Paul C. Hagenstein Day. The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Noble to contract with Greenwood Mapping to provide GIS support. The motion carried.

Joanne Hovis, CTC, advised the Board to proceed with RFI, public/private partnerships, and with State and Federal funding applications for broadband. Six RFI responses were received and it was suggested to proceed with the RFP process. It was moved by Commissioner Noble and seconded by Commissioner Rawhouser to proceed with the RFP process, to be approved by the Board, proceed with grant writing, with no funding committed, and continue to develop a strategy to move forward. The motion carried.

The Board discussed the extension of the property lease for the Rural Health Care District. Commissioner Burnette reported that a decision on the purchase of the Pinedale Clinic has been encouraged by Scott Scherbel at the next District meeting on July 18<sup>th</sup>. It was moved by Commissioner Noble and seconded by Commissioner Burnett to extend the lease to August 31, 2018 for the amount of \$10,000. The motion carried. A July 20<sup>th</sup> response was requested on the purchase of the Pinedale Clinic property.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to reduce the offer by the Board to the District by an additional \$250,000 contingent upon the following:

- The existing building which houses the Public Health Nurse and others, would not be demolished, saving the District an additional \$225,000 for this site, and making the building available for the Board to lease for the continued use of the Public Health Nurse and others.
- The District would pursue using the ballfields to re-position the CAH to allow for the Public Health Nurse's building to remain.
- The District will make their best effort, in good faith, to make a decision on the Board's offer to sell the Pinedale Clinic property by Friday, July 20, 2018.
- This reduction in cost does not supersede the Board's previous offer.
- The motion carried.

Old Business. Commissioner Rawhouser discussed Forest Service rocks. Commissioner Noble reported on the CTC meetings and the discussion of a Joint Powers Board. Commissioner Burnett reported on meeting with Joanne Hovis at Marbleton and the reliance on grants for the broadband project. Commissioner Bousman reported on the Trappers Point Rededication, conference call on sage grouse, Senate Energy Committee, and the Department of Interior re-organization hearing on Thursday. Chairman Nelson discussed the 4-H position and funding.

It was moved by Commissioner Noble and seconded by Commissioner Burnett to approve a request from Nathan & Ester Grimes, and Freeman & Tracy Crawford to change an existing lot line between Lots 165 and 166, Barger Subdivision, Fourth Filing to correct encroachments on the property line. The motion carried.

April Corwin, representing Wyoming Cowboy Challenge Academy, presented a program overview.

County Assessor Jeness Saxton discussed the proposal for oblique imagery for southern Sublette County at an estimated cost of \$76,000. The Board approved pursuing the project.

Todd Hurd, representing Forsgren and Associates, discussed the following projects:

- 1. Pinedale Fire Hall. No bids were received.
- 2. Fairgrounds. Working with Jay Brower.
- 3. Big Piney Airport storage building. Suggestions to do the project in pieces have been discussed with the Board.
- 4. Conservation District Remodel. Negotiating with Plan One Architect on pricing for design.

Mike Henn, representing the Conservation District, reported on a proposed cooperating agency meeting with Trish O'Connor for the Upper Green River Draft ROD.

Tiffany Monk, representing Tegeler and Associates, and Rob Henderson, representing Nova Benefits, presented the health insurance stop loss renewal proposals. It was moved by Commissioner Burnett and seconded by Commissioner Bousman to renew the proposal from Reliance and BCBS, for the ensuing year. The motion carried.

Lee Shannon and Shane Allen, representing Blue Cross Blue Shield, reported on their new platform and Blue Distinction Centers.

Coke Landers and Dan Smitherman, representing the local WPLI Committee, presented their report. The Board thanked the Chairmen and the Committee for their two years of work. Not action was taken on the report.
